The St Lucie County Drug Lab is located at 218 South 2nd St., Fort Pierce, and is open from 8:00am-4:30pm Mon-Fri, and 406 NW 3rd St., in Okeechobee. Call 863-824-6060 for hours of operation.

All specimens are processed on an Olympus AU400 Analyzer in Fort Pierce and a Siemens V-Twin Analyzer in Okeechobee, using Siemens and Immunalysis reagents and chemicals. Results are usually available on the same day. Results may be or emailed or viewed on our password protected web based portal, which is HIPAA compliant.

#### Family Court Cases

Some parents are reluctant to consent to time-sharing for their children in a divorce or paternity case when they suspect or know the other parent is abusing drugs.

Parents can require a clean drug screen from the other parent before time-sharing will be allowed and again afterwards, to make sure no drugs were used during time-sharing.

Simply have the parent come to the Drug Lab with a picture ID, social security number and the fee or he or she can pay the fee online at slcdrugtesting.com.

The results will be emailed or faxed to you and the other parent within a couple of hours. If you contact the Lab beforehand to let us know the parent is scheduled to submit to a drug screen, we can email you if the parent did not show up for the drug screen.

#### Criminal Cases:

The St Lucie County Drug Lab serves clients who are on Pretrial, Mental Health Court, Drug Court and Probation or supervision from other jurisdictions.

In addition, once a defendant is released on bond, it may become apparent that continued drug use may jeopardize his or her release.

Attorneys and Bondsmen can require their clients to submit to low cost drug screens at the St Lucie County Drug Lab. The results will be emailed or faxed to you within a couple of hours, or you may use the web-based HIPAA compliant password protected Drug Lab Portal to view your results.
