# ST. LUCIE COUNTY LAWNWOOD SKATE PARK RULES & REGULATIONS

ANY VIOLATION OF THESE RULES WILL RESULT IN THE PARTICIPANT'S IMMEDIATE EJECTION FROM THE FACILITY AND MAY ALSO RESULT IN LONG-TERM LOSS OF FACILITY PRIVILEGES AND/OR ARREST FOR TRESSPASSING.

## I. SKATING

- Skate at your own risk.
- All skaters, regardless of age, are required to wear a helmet when skating.
- All skaters, regardless of age, are required to have a SLC Lawnwood Skate Card physically on them when skating at the park.
- To obtain a card, all skaters must have a signed waiver on file. If the skater is under the age of 18, the
  waiver must be signed by his/her parent or guardian. Cards are currently obtained at the Havert L. Fenn
  Center adjacent to the Skate Park.
- This park was designed for skateboarders and in-line skaters only. No bicycles, scooters or motorized vehicles.
- Children under the age of 12 must be accompanied by a parent or responsible adult over the age of 18.
- Skaters must wear a shirt at all times while at the Skate Park.
- No additional obstacles, such as benches, ramps, etc. or modifications to the elements of the skate park are permitted inside the skate area or along any of the skating surface.

### II. CONDUCT

- St. Lucie County reserves the right to restrict entry to the facility and to require persons to leave the facility if any of the rules are not followed or inappropriate behavior is observed.
- The park is a drug free, alcohol free and tobacco free zone.
- Profanity, recklessness and rowdy behavior/fighting are prohibited. Engaging in any of these activities will result in your expulsion from the park and suspension of your skating privilege.
- · No littering: deposit trash in cans.

#### III. HOURS OF OPERATION

- St. Lucie County reserves the right to close the facility for any circumstances.
- Park is open during posted hours or when gates are unlocked and open. It is illegal for any person to
  enter or remain on the premises when the park is closed. Anyone at the Skate Park when it is closed will
  be subject to arrest for TRESPASSING.
- The Skate Park is considered closed if there is lightning and during and after rain. Always use caution, as weather conditions may cause unsafe surfaces and/or conditions.

### IV. PERSONAL ITEMS

- St. Lucie County is not responsible for lost or stolen articles.
- St. Lucie County reserves the right to inspect any purse, backpack, personal cooler, etc. inside the skate park.
- No dogs or other animals, except those assisting the handicapped, are permitted within the skate park.
- No glass containers of any kind are allowed in the park.
- No food OR beverages are allowed outside of the picnic tables/pavilion areas or concession area.

WARNING... There is an inherent risk in the participation of skate park activities. Users of the skate park, by participation, accept the risks inherent in such participation of which the ordinary prudent person is or should be aware. Users have a duty to exercise good judgment and act in a responsible manner while using the skate park element and obey all oral, or written warnings, or both, prior to or during participation, or both. Skateboarding and Skating are hazardous recreational activities. Use of this facility may result in serious injury including but not limited to paralysis, brain damage, concussion, broken bones and or death.
