Summary of Proposed Ordinance and Statement of Public Purpose to be Served:

This proposed ordinance seeks to amend the Airport Rules and Regulations and Minimum Standards. The Airport Rules and Regulations inform Airport users, tenants, employees, guests, and all other persons using the Airport of the precautions necessary to maintain a safe environment and explain the various policies in place at the Airport. All Airport users must comply with the Rules and Regulations.

The Minimum Standards are the standards and requirements that apply to all commercial aeronautical operators at the Airport. They foster, encourage, and ensure the economic health and orderly development of aviation and related aeronautical activities at the Airport. Minimum Standards establish transparency and clear expectations for commercial aeronautical operators that operate, or wish to operate, at the Airport. All commercial aeronautical operators that operate, at the Airport must comply with the Minimum Standards.

The Minimum Standards and Rules and Regulations (together, the "Governing Documents") were last updated in 2007. The purpose of this ordinance is to bring the Governing Documents up-to-date to reflect the changed circumstances at the Airport since 2007, and in conformity with the FAA recommendation that governing documents be reviewed and updated by the Airport sponsor regularly.

Estimate of Direct Economic Impact on Private/For Profit Businesses:

a. <u>Estimate of Direct Business Compliance Costs</u>:

The amended terms and conditions will only apply to new aeronautical businesses at the airport or existing aeronautical businesses amending their agreements with the County, so initial costs will be \$0. Costs of compliance for new businesses will depend on the activity engaged in/sought to be in engaged in at the Airport.

The Rules and Regulations will have no direct cost to users of the Airport.

- b. <u>New Charges/Fees on Businesses Impacted</u>: None on existing aeronautical businesses. New business enterprises will have to invest in facilities, as they do under existing code requirements.
- c. <u>Estimate of Regulatory Costs</u>: None in addition to existing municipal, county, state and federal permitting, licensing requirements and other preexisting regulatory fees.
